

BOROUGH OF MANASQUAN
ORDINANCE NO. 1993-07

AN ORDINANCE TO AMEND BOROUGH ORDINANCE NO. 1975-06 ENTITLED "AN ORDINANCE TO ESTABLISH MINIMUM STORMWATER MANAGEMENT REQUIREMENTS AND CONTROLS FOR MAJOR DEVELOPMENT IN THE BOROUGH OF MANASQUAN, MONMOUTH COUNTY, NEW JERSEY" FOR THE PURPOSE OF MAKING TECHNICAL AMENDMENTS REQUIRED BY THE MONMOUTH COUNTY PLANNING BOARD.

BE IT ORDAINED, by the Borough Council of the Borough of Manasquan, in the County of Monmouth and State of New Jersey, as follows:

Section 1. Borough Ordinance No. 1975-06 entitled "An Ordinance to Establish Minimum Stormwater Management Requirements and Controls for Major Development in the Borough of Manasquan, Monmouth County, New Jersey" is amended as follows:

- a. Section 1.2a., line 7 (at page 1) is supplemented to add the words "or from being exposed to stormwater." at the end of the third sentence.
- b. Section 2.1, line 3 (at page 2) is amended to delete the word "contest" and substitute the word "context".
- c. Section 2.1, line 3 (at page 2) is amended to delete the word "works" and substitute the word "words".
- d. Section 2.1, line 5 (at page 2) is amended to delete the word "work" and substitute the word "word".
- e. Section 2.1, "CAFRA Planning Map" definition, line 1 (at page 2) is amended to capitalize the word "Coastal".
- f. Section 2.1, "Major development" definition, line 1 (at page 3) is amended to add quotation marks around the fifth word.

- g. Section 2.1, "Site" definition, line 1 (at page 4) is amended to add the word "major" before the word "development".
- h. Section 3.1a.2, line 1 (at page 5) is amended to delete the word "Section" and substitute the word "Ordinance".
- i. Section 3.1a.2, line 4 (at page 5) is amended to add the word "major" in front of the word "development".
- j. Section 4.1, title (at page 6) is amended to delete the word "General" so that the title reads "Stormwater Management Requirements for Major Development".
- k. Section 4.1f.1(b)(i), lines 2 and 3 (at page 9) is amended to delete "Section 7.1" and substitute "Section 5".

Section 2. If any part or parts of this ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this ordinance.

Section 3. All ordinances or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency. All other parts of Ordinance No. 1975-06 of the Code of the Borough of Manasquan not inconsistent herewith are ratified and confirmed.

Section 4. This ordinance shall become effective immediately upon its final passage and publication as required by law.
